It assists local emergency preparedness and response efforts by providing supplies and equipment. The organization works with the Los Gatos-Saratoga Recreation and Community Education Department to see that recreation programs are provided in the mountain community which this year served more than 500 participants. This year a grant of \$10,405 was made to support these recreation programs. The foundation also encourages community participation in fundraising and community development. The foundation sponsored the Mountain Residents' Night Out, which brought 180 community members together with representatives of various public safety agencies.
